THIS PROJECT PRIMARILY HELPS HIGH SCHOOL STUDENTS IN KENYA, WHERE THE DROPOUT RATE BY HIGH SCHOOL HAS BEEN EXTREMELY HIGH. IN ADDITION TO THAT, THIS PROJECT ALSO SPONSORS A FEW STUDENTS IN UGANDA, AS WELL AS HELPS SCHOLARSHIP STUDENTS IN KENYA, RWANDA, AND SOUTH ASIA.
